**DCBIPS Privacy Statement.** The Delap's Cove Black Indian Pioneer Society will collect and retain the applicant's information and supported documents for the sole purpose to link your lineage to Delap's Cove, Nova Scotia. All applicants and members information will not be shared with other members or the public. Only authorized DCBIPS administration will have access to the information. No alterations are to be made to DCBIPS documents except by authorized DCBIPS administration. Membership is free and Citizenship will be granted with approved membership.

Please fill out all the information that applies to you and include the required documents as stated below.

## **SECTION A: Page 1-Personal Information Documents**

- Proof of citizenship: Signed Copy of your Government Issued Photo ID, Driver's License or signed copy of your Government Issued Passport Photo. The copy must contain your full name, date of birth, photo and signature with a Witness's Signature below the image and date signed to verify your identity.  
  
\***Note: Witness** must be of legal age 18 years or older, a Canadian citizen who has known the applicant for at least 2 years. If applicant is 15 years or younger, the Witness must know the parent/legal guardian for at least 2 years and is a Canadian citizen as stated above.
- If applicant's name has been changed since birth and is different from the birth certificate; include a copy of the name-linking document example: marriage certificate or legal name change certificate.

## **SECTION B: Page 2- Family Lineage Documents**

- Applicant's Long-term Birth Certificate stating Parent(s) name(s) with Mother's maiden name.
- If the applicant was adopted, the Long-term birth certificate must list the name(s) of the adoptive parents.
- If applicant has an Aboriginal Status, please include a copy of the Status card.

## **SECTION C: Page 3-Supporting documents**

- List the documents included with your application in the spaces provided on page 3.
- Copies of all documents linking the applicant to Black Mi'kmaq settlement of Delap's Cove, Annapolis County, Nova Scotia. Document example's: Birth Certificates, Death Certificates, Baptism Records, Marriage Certificates and Aboriginal Status Card.
- Review your information and document copies to ensure you have all the required information to submit your application.

## **SECTION D: Page 4- Proof of citizenship and Declaration and Signature**

- Proof of citizenship: Witness Signed Copy of your Government Issued Photo ID

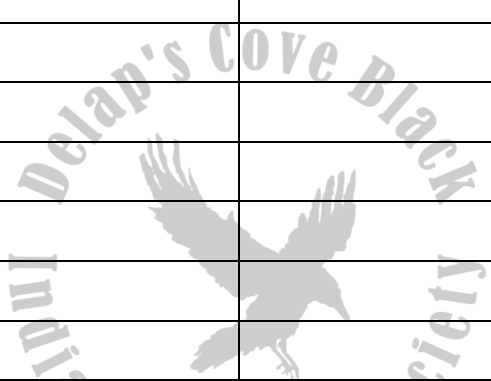

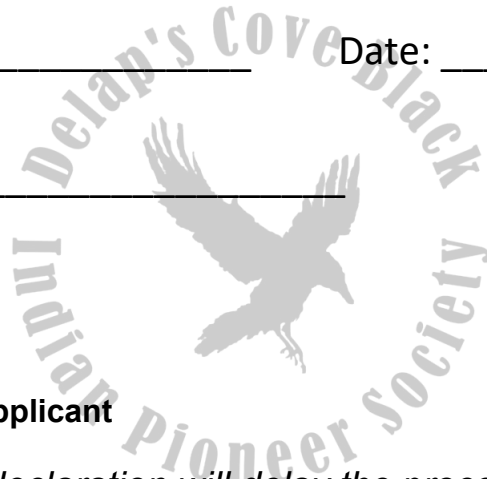
